

#### TIME FRAME FOR FORMS TO BE COMPLETED

#### 1. 10.5 Certification of Notice

Personal representative(s) gives notice to all beneficiaries/heirs

#### 2. /Inheritance Tax Forms

Two must be sent back to ROW (1 must have original signature; ROW sends to Harrisburg)

#### Inventory

List all estate assets

#### 3. 10.6 Status Report

Send back after documentation received from Department of Revenue that inheritance taxes have been paid in full) Due within 3 months from the date Letters Granted *Must be completed in ink.* 

Due within 9 months from date of death 3 months for 5% discount – filed and paid *Must be completed in ink.* 

Due within 9 months from date of death *Must be completed in ink.* 

Due 2 years from date of death – **and** if administration has not been completed, annually thereafter until administration of estate is complete *Must be completed in ink.*
