Under the 2007 Bucks County Open Space Bond Initiative, \$26 million has been allocated to the Municipal Open Space Program to provide municipalities with financial assistance for open space planning and acquisition. In addition to a base allotment of \$200,000, each municipality is eligible to receive an adjusted share based on its percentage of overall county land area and population.
