<b>VII. ON-SITE SEWAGE DISPOSAL</b>	
<b>A. FEES FOR SITE EVALUATION, SUBDIVISION REVIEWS AND REPAIRS:</b>	
For the purpose of determining the number of lots in a subdivision under this section, that part of a multiple family dwelling or commercial or industrial establishment with flows equal to 400 gallons per day is equivalent to one (1) lot or EDU.

(b) Act 537 Subdivision Plan Review Including Lot By Lot Testing (Lot by lot testing includes one (1) field evaluation of each lot and a written report of findings)	\$825.00 per lot
(c) Additional field evaluations of a lot will require an additional fee for each evaluation report	\$270.00
(d) Act 537 Subdivision Plan Review and general field evaluation Without Lot By Lot Testing	\$270.00

<b>B. APPLICATION FEES FOR ON-SITE SEWAGE PERMITS</b>	
All permit application fees will be based upon one (1) "equivalent dwelling unit" (EDU), which is equal to an estimated sewage flow of 400 gallons per day. Fees will be increased proportionately for each additional EDU or rounded up to the next whole number if a fraction thereof. Any single family residence located by itself on an approved lot will be considered one (1) EDU regardless of the estimated flow. Sewage flows for Community and Non-Residential Facilities will be estimated in accordance with 25 PA code Chapter 73, Section 73.17.	
Application fees are <b>non-refundable</b> whether a permit is issued or denied. Application fees cover review of the application and inspections of the system. <b>Application fees do not cover the on-site evaluations necessary to support the application.</b> See Section A above for evaluation fees.
