- Cancellation Policy: Permits may be cancelled in writing 7 working days prior to the rental date for a \$10 fee. If less than 7 days notice, no refund will be given.**
- Checks and/or money orders are payable to "Bucks County Department of Parks and Recreation" for full amount of rental plus tax and security deposit, when applicable.
- Signed permits must be made available for inspection by Department employees or representatives at all times during park occupancy and additional identification may be requested by a **park ranger**.

Applications may be made by mail, in person, or by telephone and will be processed on a first come first serve basis

All fees are payable in advance by cash, check, money order, Visa or MasterCard. No application will be completed without full payment or information needed to complete the application.
